About the Position

The Data Analyst will play a pivotal role in the debt data process management. Duties and Responsibilities

Debt Data Management

- Normalize the acquired data and align it with the organization's specifications and standards.
- Generate insightful reports that aid in decision-making for debt portfolio purchasing and forgiveness.
- Collaborate with the Debt Operations, Information Systems and Development departments to process, analyze, and review debt files.
- Conduct qualification tests to ensure debt portfolios align with donor requirements and the company's tax-exempt objectives.
- Deliver comprehensive reports detailing metrics such as the number of debtors assisted, value of debt abolished, and more, supporting the Debt Operations department's reporting efforts.

Data Analysis and Improvement

- Extract actionable insights from the data to drive continuous improvement in the debt purchasing and abolishment process.
- Respond to inquiries from trading partners regarding data specifications and requirements.
- Partner with the Information Systems department to define technical requirements for systems used in debt data management.
